**RESOLUTION NO. 03-2011**

**A RESOLUTION DECLARING THE NECESSITY OF REPAIRING CERTAIN SIDEWALKS IN THE VILLAGE OF ARLINGTON, OHIO, AND REQUIRING THE ABUTTING PROPERTY OWNERS TO REPAIR THE SAME AND DECLARING AN EMERGENCY.**

WHEREAS, the Village Engineer has heretofore prepared plans, specifications and estimate of cost for the repair of a certain sidewalk at the location(s) hereinafter set forth, and;

WHEREAS, said plans, specifications and estimate of cost are now on file in the Office of the Fiscal Officer.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Arlington, State of Ohio:

SECTION 1: That it is necessary to repair a certain East-West sidewalk in the Village of Arlington, Ohio, at the following location:

202 W. Main Cross Street  
Arlington, Ohio 45814

Situated in the Village of Arlington, County of Hancock,  
State of Ohio:

T2S R10 S01  
N. Main CR SE1/4

Tax Parcel No. 310000075140

SECTION 2: That the plans, specifications and estimate of cost for said repair now on file in the Office of the Fiscal Officer be and the same are hereby approved.


SECTION 3: That the owners of the lots and parcels of land abounding and abutting upon the proposed sidewalks to be repaired shall repair that portion of said sidewalk ordered to be repaired which abuts their properties, in accordance with the plans and specifications now on file in the Office of the Fiscal Officer, within ninety (90) days from the date of passage of this Resolution.


SECTION 4: That in the event any such abutting property owners do not complete the repair of that portion of such sidewalk which abut their property in accordance with said plans and specifications and within the time period as herein before prescribed, then this Council shall cause the same to be done and the entire cost thereof, shall be assessed upon the property of such abutting property owner.

SECTION 5: That the Fiscal Officer be and she is hereby authorized and directed to serve notice of the passage of the Resolution upon the owner of the lot and parcel abutting upon said sidewalk in the manner provided by law.

SECTION 6: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Arlington, Ohio and for the further reason it is necessary so that said sidewalks may be repaired during the coming construction season.

WHEREFORE this Resolution shall be in full force and effect from and after the earliest period provided by law.
